HEARINGS/OTHER SCHEDULED MATTERS

FY2019 TAX CLASSIFICATION HEARING

Don Frigoletto indicated that the Board of Assessors recommends that the Board of Selectmen adopt a residential factor of one (1).

W. Walker made a motion to accept a residential factor of one (1), which will result in all classes (residential, commercial, industrial, and personal property) being taxed at the same rate in FY2019 and to authorize the Assessors to signify the Board of Selectmen's approval electronically if required. The motion was seconded and passed unanimously.

BOND ANTICIPATION NOTE - FIRE TRUCK

Melody Smith was present to request the approval of a Bond Anticipation Note in the amount of \$600,000 for a Fire Truck with Greenfield Cooperative Bank at an interest rate of 2.60%.

W. Walker made a motion to execute the Bond Anticipation Note Renewal, in the amount of 600,000 for a term to run 12/27/18-12/27-19 with Greenfield Cooperative Bank, at an interest rate of 2.60%. The motion was seconded and passed unanimously.

INTERFUND BORROWING - WATER TANK

W. Walker made a motion to approve an Interfund Borrowing for \$77,000 from Stabilization to put toward the Ellis Road Water Tank Project. The motion was seconded and passed unanimously.

2019 SENIOR TAX WORKOFF PROGRAM

W. Walker made a motion to approve the updates to the Senior Tax Workoff Program for 2019, which include giving the maximum benefit allowed under the law. The amount of credit available to the senior will increase from \$1000 annually to \$1500 annually. The motion was seconded and passed unanimously.

APPOINTMENT - ASSISTANT ANIMAL CONTROL OFFICER

W. Walker made a motion to appoint Nina Decot as Assistant Animal Control Officer, based on the recommendation by Acting Chief Mike McDonald. The motion was seconded and passed unanimously.

NEW BUSINESS

TAX DELINQUENT PARCEL REVIEW

Melody Smith, Treasurer/Collector and Steve Wallace, Town Planner updated the Board on the current properties in town that are under tax title. The properties on this list range from vacant locations, owner unknown properties, properties where the owner has a valid payment agreement, foreclosures and land court cases.

The Board discussed the list of properties in tax title as well as the value associated with the unpaid taxes.

WACHUSETT BREWING PARKING LICENSE EXTENSION
