## NOI 9 Hill Road Garde

The public hearing was opened as requested by Brandon Garde for replacing four existing retaining walls at 9 Hill Road and for grading within the back yard. Scott Jordan of Eco Tec provided proof of notification of abutters and publication of the legal notice. Also representing Mr. Garde were landscapers Jake Szeredy and Kevin White. Their intent was to remove and replace the existing 3 upland retaining walls as well as 1 retaining wall along the shore of Wyman Pond. The progression of work was discussed as well as the timing of project and the many variables including the unknown date for the draw down and possibility of heavy rain. The sequence of work was discussed and Dan Bartkus suggested that work should be from top down. Contingency plans were discussed. The Commission voted to continue to the next meeting and requested a sequencing plan and erosion control options. Matt Marro will meet with the landscapers at the site and make recommendations.
