7:10 pm. The public meeting for a removable aluminum dock project on Wyman Pond belonging to William and Walter Wintturi of Honey Bee Lane was opened. Walter Wintturi represented and noted that the dock was not within regulations prior and this filing is a retroactive filing. It is in the lake 4 out of 12 months. Robert Gendron recused as a member. He did reserve the right to comment as an abutter. Mr. Gendron commented that the dock was hit by a boater and he feels it is too long for the area. He also noted that due to the length of the dock into the channel, the boats are slowing and creating a wake and eroding his shoreline. Burt Gendron also commented that the lot is not to be built on. Mr. Marro noted as the application represents a dock that is temporary in nature and removed seasonally it does not require a chapter 91 license. He requested that the dock be moved over and around the corner on the lot and the “big” part of the lake. Mr. Sheehan noted that the

shoreline should be monitored across the way from the property. The chair agreed. Mr. Sheehan moved for a negative determination. Ms. Monty seconded and the commission voted unanimously.

Enforcement Order 220 Worcester Road:

Gene LeBlanc appeared at the meeting with Maryann Dipinto and Chris Mossman regarding the placement of a dock/ramp at the duplexes at 220 Worcester Road. Ms. Dipinto and Mr. Mossman also presented a plan they will be filing a Notice of Intent which would create a "marina" area and extra land under water. There may be a wildlife habitat analysis necessary. A chapter 91 and 401 water quality certificate would be required.
