Ongoing PFAS Situation

Please be advised that in the area around 65 Bean Porridge Hill Road, toward South Ashburnham Road and surrounding neighborhoods, drinking wells have tested positive for PFAS contamination beyond the limits set by the Massachusetts Department of Environmental Protection. MassDEP is overseeing the contamination investigation and remediation efforts in these areas; two licensed site professionals are working with residents to have their wells tested, provide temporary measures like bottled water and well filtration until a permanent solution can be determined. Additionally, the surface water of Crocker Pond has been tested in accordance with Department of Public Health protocols and the results will be shared on the town website, Crocker Pond Facebook pages and an e-alert in advance of opening the beach for the season.
