# Town of Westminster - Select Board Meeting Minutes - Monday, April 10, 2023

## **CALL TO ORDER**

S. Albert called the meeting to order at 6:30 PM in room 205 of the Town Hall. He announced that the meeting was being recorded and broadcast live by Ashburnham/Westminster Community Media.

#### **ANNOUNCEMENTS**

S. Albert made two announcements:

Thank you to the Parks & Recreation for the Easter Egg Hunt, which was a great success along with the assistance of the Fire Dept. There were hundreds of people in attendance far more than last year. Great job done by Parks & Rec.

The Annual Town Election will be held on Tuesday, April 25<sup>th</sup> from 7:00 AM to 8:00 PM at the Senior Community Center, 69 West Main Street.

In addition to voting for your local officials, there are two non-binding ballot questions regarding the future of the Old Town Hall building & property.

#### Question One:

- Should the Town of Westminster retain ownership of the old Town Hall property at 3 Bacon Street for repurposing, up to and including demolition; utilizing available State, Federal or other grant funds?

A YES vote on this question would lead the Town to retain ownership and control over the parcel and building. Future options could include demolishing the building to build a playground or outdoor park, add parking for the library, and/or provide public green space for gathering in the town center. This measure would be funded, to the greatest extent possible, by federal, state or other grant funds and not the tax levy.

#### Question Two:

Should the Town of Westminster sell the old Town Hall property at 3 Bacon Street for repurposing with a historic preservation restriction?

A YES vote to this question would lead the Town to a second phase; the distribution of a survey at the November Special Town Meeting, to help direct the wording and requirements of the Request for Proposals (RFP) to sell the building. This would give the residents an opportunity to have input on the RFP.

Once declared surplus, the Fire Department has requested to utilize the town maintenance truck for training exercises. The motion was seconded, vote was unanimous.

## ANNUAL TOWN ELECTION WARRANT:

H. Billings made a motion to vote, approve and post the Annual Town Election Warrant. The election will be held on Tuesday, April 25, 2023 at the Community Senior Center at 69 West Main Street from 7:00 am to 8:00 pm. The motion was seconded and passed unanimously.

## PULBIC SAFETY BUILDING COMMITTEE - UPDATE CHARGE AND MEMBERSHIP:

H. Billings made a motion to approve the charge for the Public Safety Building Committee and appoint the following members to fill the vacancies on that committee. The Board will also need to designate a member to serve. After discussing which Select Board member would be on the committee, it was agreed that M. Banks would be on the committee as a Select Board Liaison.
