### **Emergency Management Member:**

M. Banks made a motion to approve payroll authorization for Joshua Mills for emergency Management member, as recommended by the Fire Chief. The motion was seconded and passed unanimously.

### Recruit Firefighter:

M. Banks made a motion to approve payroll authorization for Matthew Amendola as Recruit Firefighter, as recommended by the Fire Chief. The motion was seconded and passed unanimously.

## CONTRACT COMMUNITY OUTREACH CLINICIAN (POLICE):

M. Banks made a motion to approve the contract with Colleen Cole as Community Outreach Clinician working with the Police Department. The motion was seconded and passed unanimously.

### **BOARD OF ASSESSORS - BALLOT VACANCY:**

M. Banks made a motion to approve a vacancy on the ballot for the Board of Assessors. This is a requirement to allow nominations for the position at the Caucus or for a write in candidate at the Annual Town Elections. The motion was seconded and passed unanimously.

### MARCH 5, PRESIDENTIAL PRIMARY WARRANT:

M. Banks made a motion to approve and post the presidential primary warrant, to be held March 5, 2024 at the Westminster Senior Center, 69 W. Main Street. Polls will be open from 7:00 am – 8:00 pm. The motion was seconded and passed unanimously.

## EMERGENCY MEDICAL PREPAREDNESS GRANT CONTRACT (EMPG):

M. Banks made a motion to approve the contract with the Massachusetts Emergency Management Agency (MEMA) for an equipment trailer to house emergency shelter supplies on site at the Public Safety Building. The motion was seconded and passed unanimously.

#### **NEW BUSINESS:**

#### FLAG POLICY:

M. Banks made a motion to approve and adopt the Flag Policy for the Town of Westminster. The motion was seconded and passed unanimously.

Town Counsel has recommended that the Town adopt an official flag flying policy following the Supreme Court ruling against the City of Boston. Counsel has provided the policy which mirrors the town's current and past practice.

#### **INITIAL BUDGET REVIEW:**

Budgets were distributed to the Board earlier this week, since that time the Pension assessment has been received and other departments have finalized their submissions. The Advisory Board began their review this week as well. If the Board wishes to call in specific departments to discuss their budget requests, this can be scheduled for the 2/12 or 2/26 meetings. Non-money article requests are due February 16, along with Small Project Requests.

The Board would like to meet with Police, Fire, Town Clerk, Cemetery and Library Departments on the February 26<sup>th</sup> meeting. The School will be at the February 12<sup>th</sup> meeting.
