WARRANTS:

S. Albert made a motion to approve the following warrants:

MassDEP Technical Assistance Grant – LSP Services:

Albert made a motion to vote and execute the contract for \$20,000 grant from the MassDEP for the Board of Health to engage with a Licenses Site Professional (LSP) to assist the Town in managing the next steps of the PFAS contamination on and around Bean Porridge Hill Road. The motion was seconded and passed unanimously.

Police Lieutenant:

S. Albert made a motion to vote and execute the contract with Jason Tamulen, as Police Lieutenant, from July 1, 2024 to June 30, 2027. The motion was seconded and passed unanimously.

Deputy Fire Chief:

S. Albert made a motion to vote and execute the contract with Adam Bean, as Deputy Fire Chief, from July 1, 2024 to June 30, 2027. The motion was seconded and passed unanimously.

ONGOING BUSINESS/MISCELLANEOUS

216 ASHBURNHAM STATE ROAD — PURCHASE & SALES AGREEMENT:

S. Albert made a motion to vote and execute the Purchase & Sales Agreement for 216 Ashburnham State Road, authorized at the May 6, 2023 Annual Town Meeting for a purchase of \$320,000. The motion was seconded and passed unanimously.

NEW BUSINESS

VOLUNTARY EMPLOYEE BENEFITS PRESENTATION — PERSONNEL ADMINISTRATOR:

C. Martineau was present at this meeting to present, for the Board's endorsement, a suite of voluntary benefits we would like to offer and administer for employees. This benefit package will be 100% employee pay and at zero cost to the Town. The rates provided to staff are well below the market rate and will be offered as payroll deductions for ease of use. The benefits include, Short and Long Term Disability, Legal Assistance, Enhanced Vision Coverage and Identity Theft Protection.

Cindy also presented the potential to offer a health insurance buyback program, in light of the current premium and potential future premium increases there is a benefit to the Town and staff to offer financial incentive for employees to come off the health plan.

If approved, Cindy wants to present a Benefits Fair at the Senior Center with the representatives from each endorsement so employees, if interested, could find out more and could sign up that day.

S. Albert made a motion to endorse the benefits offerings to employees and the insurance buyback program. The motion was seconded and passed unanimously.
