DISCUSSION: PUBLIC BUILDING CODE OF CONDUCT

The Town Administrator attended a Massachusetts Municipal Managers Association conference over the summer highlighting the topic of "Bringing Civility Back to Town Hall". This was covered due to an increase in highly confrontational interactions between customers and public employees on the local, state and national level. In the recent past, there have been multiple instances where employees have been cursed or shouted at, or generally made to feel unsafe because of the behavior of visitors in this building and

others. This month, a panic alarm was engaged due of the actions of an individual visiting the building for services.

In an effort to prevent this behavior, encourage patience, professionalism and most importantly protect the staff and other visitors to the Town Buildings; the Town Administrator would like to request that the Town draft and adopt a Public Buildings Code of Conduct for the public spaces in Westminster. Town Employees and Elected/Appointed Officials are governed by our respective handbooks however at this time is there is no "official" documentation or policy for the expectation of behavior of those visiting our buildings.

The Select Board decided to work on wording and take it up at a future meeting.
