Agents Update:

Health Agent has had difficulty attaining accurate numbers and addresses of cases of Covid-19 isolation status from the central data base.

Worcester County Emergency Preparedness Region 2 Coalition is able to supply some personal protective equipment to local BOH, needs to be distributed to specific facilities as defined by MEMA.

Ms. Loree has been working with store managers on the number of people entering stores.

Board re-iterated that Title V inspections shall continue though limited to as needed basis. With focus on ability to maintain a minimal 6 feet distance for the safety of our staff & residents.

Home owner needs to present a suitable site and design for the system in compliance with 310 CMR 15.00 and the Westminster Regulations 245.

Board suggested homeowner get a Title V Scan water test to determine if well contamination is being caused by effluent.

64 West Princeton Road: Building Permit request for remodeling with added bedroom. Home owner had exceeded the limitation of bedrooms the septic system can handle with this addition. BOH required the home owner to register a Deed Restriction prior to a signing a building permit.
