Call to Order

Mr. Ed Simoncini called the meeting to order at 4:31 in room 205 of the Town Hall. He announced that the meeting was being recorded.

Hearings:

Old Business:

- ➤ PFAS Updates- Mr. Larry Lessard and Mr. George Hailer were present to update the Board on PFAS. The Board posed questions to them, and their response is they will update their FAQ's on the website, so the public as well as the Board can view them.
- Multi Use Fields Project no updates
- Status of current Health Agent replacement Ms. Abigail Conlin notes that the new Health Agent is scheduled to begin on October 3rd, rather than mid-September, raising concerns from the Board that the start date keeps being moved out.
- ➤ Discussion on current septic and well regulations. Mr. Ed Simoncini is working on a draft with both Mr. Matthew Pearson, and Dr. Michael Popik's notes. The board hopes to have a working meeting within the next month or two.

Assistant Health Agent updates-

Ms. Abigail Conlin reports that the outstanding Title 5 inspection reports from 2 inspectors have been turned into the office, and we no longer have any outstanding. Abigail states she will be looking at the due dates more carefully as they get close to be sure this doesn't become an on-going issue.

Ms. Abigail Conlin reports that the office received a beaver trapping application, and questioned what the office should do. Mr. Ed Simoncini made a motion to approve the application and allow Ms. Abigail Conlin to sign them. Motion was seconded by Dr. Michael Popik. All in favor- 3-0 Unanimous. Vote to approve.
