ONGOING BUSINESS/MISCELLANEOUS

ADOPTION OF UPDATED HOUSING PRODUCTION PLAN

Wallace indicated that DHCD has completed its review of the updated Housing Production Plan that was revised for the town by MRPC and preliminarily approved by the Board of Selectmen on February 5. DHCD did not see a need for any edits, so the next step in the process is to vote to formally adopt the plan.

W. Walker made a motion to adopt the updated Housing Production Plan for the next five years, as presented by the Town Planner. The motion was seconded and passed unanimously.

RECREATIONAL MARIJUANA BYLAWS

The Board discussed the potential recreational marijuana bylaws for the Town. The Board raised questions regarding the definition of a "marijuana establishment" as well as how to go about limiting the number of licenses available in town.

The Board indicated that at this time they would like to prohibit the retail sale of recreational marijuana in Westminster and to limit the number on non-medical cultivation facilities to less than the number of medical facilities.

The Board is going to reach out to Town Counsel with its questions and revisit the issue at a later date.
