An extension may be granted for good cause if requested in writing and approved by the Wiring Inspector.

Permit fees doubled upon failure to apply for a permit and pay the appropriate fees as required by *MGL 143 Section 3*

**Permit fees may be waived ONLY by the Board of Selectman in writing

Re-inspection fee will be \$50.00 for violations and work not completed per inspection

PLUMBING / GAS FEES

Effective July 1, 2013

(Plumbing Permits and Gas Permits are TWO separate permits and fees)

RESIDENTIAL & COMMERCIAL

New Construction - Plumbing	\$160 + \$5 per fixture
New Construction - Gas	\$80 + \$5 per fixture
Plumbing and or Gas Renovations/Additions	\$80 + \$5 per fixture
Underground propane lines from tank to building	\$80 + \$5 for generator or
Gas piping re-tests	pool heater only
Each dwelling unit requires a separate permit for	\$40

RESIDENTIAL & COMMERCIAL REPLACEMENTS

Replacement or installation of gas, oil, electric	\$40
water heaters, storage tanks, gas stoves, water	
conditioners, tank less coils, back flow preventers	
or any other Plumbing or Gas related equipment	
New Construction - Gas	
Re-inspection Fee	\$40

Total fees for all permits and inspections may be determined by the Plumbing and Gas Inspector according to the above schedule and/or not to exceed 10% of the building permit fee for the construction and/or 2% of the value of the plumbing and/or gas work.

NOTE: In addition to the permit fee, a penalty of double the fee will be charged if work is begun before a permit is issued and/or in violation of the provisions of 248 CMR, Section 2.04 (3).

As per 248 CMR, Section 2.04(3)(B): the repair of leaks in a faucet, value, or other working part of a plumbing fixture, and the clearance of a stoppage: but not including the alteration, replacement or relocation of any faucet, value, or other working part of a plumbing fixture or device, water supply, sewer, drainage, leader soil, waste, vent or similar piping or work affecting public health shall be deemed a minor repair for which no permit shall be required
