Dan Bartkus called meeting to order at 7:00 p.m. The meeting was not recorded.

Minutes and Mail

The following Minutes were approved:

Enforcement Order ~ 71 rear Knower Road – Dean Johnson

7:00 p.m. The Conservation Agent issued an Enforcement Order to Mr. Johnson after the collapse of a chicken coop within the 100 ft. buffer zone to the wetland on July 1, 2015. In the Enforcement Order, Mr. Maki requested that silt fencing or hay bales be immediately installed across the entire rear of the building and that Mr. Maki be notified upon installation. Mr. Johnson appeared before the Commission along with friends, neighbors, and relatives from Westminster and other towns. Mr. & Mrs. Johnson were quite distressed with the Enforcement Order. Mr. Johnson stated that he had purchased the silt fence but wasn't able to install it because of the hard packed gravel and would have to rent a trench digger. Dan Bartkus had talked with Mr. Johnson and informed him that hay bales would not be necessary as long as the silt fence was installed. Mr. Johnson stated that farms were exempt from review for work within the scope of normal maintenance or improvement of agricultural land within the 100 ft. buffer. The silt fence had not been installed, and after lengthy discussion, Dan Bartkus agreed to stop by Johnson's Farm on Friday to show them where to install the silt fence. Discussion ended at 7:20 p.m.

1 Virginia Avenue / Order of Conditions

The Commission unanimously voted to deny the Order of Conditions for 1 Virginia Avenue on June 11, 2015. Sufficient information was not provided regarding the displacement of the proposed building and its compensatory storage on site as well as the configuration of the septic design. Conservation Commissioners signed the Order of Conditions.

RFD 7 South Street Westminster Police

7:30 p.m. The public meeting for the Request for Determination of Applicability by Salvatore Albert of the Westminster Police Department for the installation of a precast slab on crushed stone was opened. After brief discussion, a motion was made to approve after recommendation by the Conservation Agent. The motion was unanimous to approve the plan. The public meeting was closed at 7:32 p.m.

RFD 75 Town Farm Road Greenstone Realty, LLC

7:32 p.m. The public meeting for the Request for Determination of Applicability by Greenstone Realty, LLC for the reconstruction of a home destroyed by fire and previously demolished, the reestablishment of utility connections and upgrade of the septic system at 75 Town Farm Road was opened. Mark Popham represented the applicant. The fire-damaged house and foundation have been demolished. The proposed house will be in a new location. An unnamed perennial stream was discussed. Bob Maki had visited the site and upon his recommendation, the Commission unanimously voted to approve after a motion was made by Gary Smith and second by Robert Gendron. The public meeting was closed at 7:40 p.m.

RFD 1 Laurie Lane LaRoche

7:40 p.m. The public meeting for an addition to a home at 1 Laurie Lane was opened. Jane LaRoche was present and discussed the proposed project. The addition would be 26 ft. x 32 ft. Bob Maki advised that a RFD be filed. The plan was unanimously approved upon motion by Robert Gendron and second by John Regan. The public meeting was closed at 7:45 p.m.

NOI 69 Old Oak Avenue Brown

7:45 p.m. The public hearing for the extension of a porch area at 69 Old Oak Avenue was opened. Paula Brown explained her intention. Silt fence was shown of the sketch. The Commission voted unanimously to approve. The public hearing was closed at 7:50 p.m.

ENFORCEMENT ORDER / 71 rear Knower Road

The Commission unanimously voted to sign the Enforcement Order.
