Dan Bartkus called the Zoom meeting to order at 7:03 pm. The meeting was recorded by Matt Marro.

RFD 58 Knower Road Kotsonas

7:06 pm The Chairman opened the public meeting requested William Kotsonas for the installation of a replacement septic system to serve an existing single family house at 58 Knower Road. Matt Marro shared the plan and Chris Mossman gave the overview of the project. A portion of the work is located within the 100 ft. buffer zone of a bordering vegetated wetland area. Impacts to the wetland area will be minimized using silt fence. Matt Marro visited the site and stated that this project qualifies for a negative determination. Tim Sheehan made a motion to approve as a negative determination; Carrie Monty seconded the motion. A roll call vote was called and the motion passed unanimously. The public meeting was closed at 7:10 pm.

59B East Road Gary Streeter, East Road Realty Trust

7:10 pm The public hearing requested by Gary Streeter for the for the installation of a concrete block retaining wall along the shore of Wyman Pond for an existing single family house was opened. The plan was shared for remote participants to view. The boat traffic is causing the bank to erode and become undermined. Work will be scheduled when the annual draw down has been completed and impacts on the resource area are expected to minimal. A wildlife habitat assessment was discussed was included. Matt Marro had no issue with this project. Rob Gendron recused himself but reserved his right as an abutter. The use of marape cloth to help prevent erosion was discussed. With no further questions, the motion passed upon motion by Tim Sheehan and second by Carrie Monty. The public hearing was closed at 7:18 pm.

7:19 pm. The public hearing requested by Andrew Delorme for the installation of a tight tank and new well for an existing single family house at 2 Beach Circle was opened. The plan was shared for remote participants to view. Chris Mossman explained the project and the situation of Baker's Grove. Each individual owns their camp but the land is owned by Baker's Grove Association. This project has been approved by the Board of Health. Rob Gendron recused. A roll call vote was called and the motion passed. The public hearing was closed at 7:22 pm.

Route 2 Maintenance Project MASS Department of Transportation

7:22 pm. The public hearing requested by Massachusetts Department of Transportation for a maintenance project on Route 2 was opened. Matt Marro shared the plan for remote participants to view. Susan McArthur of McArthur Environmental Consulting and David Goldstein of Mass DOT discussed the project consisting primarily of milling and resurfacing and replacing

substandard guardrail. Side slopes will be cleared and grubbed and drainage structures will be adjusted. Filter tubes will be installed in down gradient areas. After review, Tim Sheehan made a motion to approve as a negative determination. The motion was seconded by Carrie Monty. The project was unanimously approved by roll call vote. The public hearing was closed at 7:27 pm.

CONTINUATION NOI Lot B -13 A White Pine Drive Carlson / Traditional Concepts

Wes Flis requested a continuation to the next meeting. The road is scheduled to be completed and Mr. Carlson hopes to close the enforcement at that time. The Commission voted to continue the hearing. Dan Bartkus recused from the vote.

17 Wachusett Drive

Matt Marro discussed field changes requested by Kevin Young for 17 Wachusett Drive. Several changes were discussed including the retaining wall, handicapped access, large hot tub, tree removal, plantings, and a shed. The Commission granted approval to continue to work on the approved project, but to return to the next meeting showing a new plan and all the proposed changes alongside the existing plan.
