Mail, Minutes, Voucher

Mail was read and distributed. The Minutes of August 22, 2019 were approved. A voucher for dues for MACC \$287.00 and Nashua River Watershed \$50.00 was approved.

RFD Continued Lot 3 Minott Road Forest Hill Realty Trust

7:10 pm. The continuation of the public meeting requested by Forest Hill Realty Trust for a single-family, with driveway, and septic was opened. DCR granted a variance for the current version of the plan. The plan was unanimously approved with the recommendation of Matt Marro.

NOI 100 Simplex Drive Salter / Great Northern Dunnage, LLC

7:15 pm. The public hearing requested by Roy Salter on behalf of Great Northern Dunnage, LLC for the treatment and discharge of dewatered ground water during the construction of eight load bays located at 100 simplex drive, and owned by William Deshler was opened. Dena Tomassi of EnviroTrac Ltd. represented the owner and gave the overview of the project. The site environmental status was discussed. Chlorinated volatile organic compounds have been identified in the ground water. The Commission had concerns and questions about the treatment system for the dewatering. The hearing was continued to October 24, 2019 to give Ms. Tomassi an opportunity to research the questions and report back to the Commission.
