5:00 PM Opened Meeting at Public Works Department Office. Reviewed correspondence and signed bills for payment.

5:01 PM Commissioner Butterfield made a motion that the Commission sign the Order of Taking for Bathrick Road easements. The motion seconded by Chairman Emerson. Voted unanimously.

5:02 PM Commissioner Butterfield made a motion that the Commission sign the MassDOT Chapter 90 10-year contract. The motion seconded by Chairman Emerson. Voted unanimously.

5:05 PM Commissioner Butterfield made a motion that the Commission approve the meeting minutes of March 20, 2017 as written. The motion seconded by Chairman Emerson. Voted unanimously.

5:06 PM Commissioner Butterfield made a motion that the Commission sign the Sewer Accounts commitment for the month of March 2017 in the amount of \$875.96 and the Water Accounts commitment for the month of March 2017 in the amount of \$721.45. The motion seconded by Chairman Emerson. Voted unanimously.

- 5:30 PM Commissioner Butterfield made a motion for the Chairman to sign the payroll authorization for the new Water and Sewer Department Truck Driver/Laborer Timothy Glasson as recommended by the Director of Public Works. The motion seconded by Chairman Emerson. Voted unanimously.
