PUBLIC WORKS COMMISSION MEETING MINUTES

August 22, 2016

6:00 PM Opened Meeting at Public Works Department Office. Reviewed correspondence and signed bills for payment.

6:01 PM Commissioner Butterfield made a motion that the Commission approve the meeting minutes of August 8, 2016 as written. The motion seconded by Chairman Emerson. Chairman Emerson and Commission Butterfield voted in favor. Commissioner Ryder did not vote.

6:04 PM Commissioner Butterfield made a motion to have the Chairman sign the Sewer IMA letter addressed to the City of Fitchburg to start negotiations for a new agreement. The motion seconded by Commissioner Ryder. Voted unanimously.

6:05 PM Pole Petition Hearing Turnpike Road

Chairman Emerson opened the public hearing. David Pasch from UC Synergetic representing Verizon presented the project. The Director of Public Works had concerns with the proposed new pole location and its proximity with the existing pole 19. Mr. Pasch acknowledged the concern and would look into the ability to relocate pole 19. Commissioner Butterfield made a motion to close the public hearing. The motion seconded by Commissioner Ryder. Voted unanimously. Chairman Emerson closed the public hearing at 6:20 PM. Commissioner Butterfield made a motion to deny the pole petition request on Turnpike Road. The motion seconded by Commissioner Rdyer. Voted unanimously.

Other Items

- The Director discussed the possibility of having a Construction and Demolition (C&D) container at the Solid Waste Drop-Off Center. The material in the C&D container could be recycled and would not be deposited in the landfill as Municipal Solid Waste. The Director plans on discussing this with Waste Management.
- The Director gave an update on the water restriction and drought status in Town and in Massachusetts.

- The Director discussed with the Commission Town Counsel's comments/opinion on the road status of Lake Drive West and Partridge Hill Road.
- The Director gave an update of the Whitman River Sewer System Improvements Project.

- The Director gave update on the Bacon Street sidewalk replacement project.
- The Director discussed the Route 140 reconstruction project RFR and will have a draft of the RFR in early September for the Commission to review.
