Pool Filling Abatement Policy

The Director discussed with the Commission the current procedure for requests from pool owners for sewer credit when topping off/filling swimming pools. The Commission agreed that property owners requesting sewer abatement for pool filling must install a deduct meter per the current policy for sewer credit for outdoor water usage. The Director will draft a letter to send to pool owners that have requested abatements in the past. This requirement will be effective January 1, 2017.

DPW Capital Plan

The Commission discussed the recent meeting with the Capital Planning Committee regarding the Public Works 5 year capital plan and large capital items.

6:43 PM Commissioner Butterfield made a motion to grant The First Congregational Church's request to close portions of Bacon and Pleasant Streets on Saturday, August 27, 2016 from 9:00 a.m. to 4:00 p.m. for the Annual Yankee Street Fair. - The Commission discussed the recording of a disclaimer of instrument of taking for private roads taking by tax title by the town with unknown owner as recommended by town counsel because the town failed to identify the correct owners
- Commissioner Ryder discussed the possibility of the developer of the Village at Old Mill subdivision moving forward with a road acceptance petition this year
