6:00 PM Opened Meeting at Public Works Department Office. Reviewed correspondence and signed bills for payment.

6:01 PM Commissioner Barber made a motion that the Commission approve the meeting minutes of January 14, 2019 as written. The motion seconded by Commissioner Butterfield. Voted unanimously.

6:02 PM Commissioner Butterfield made a motion that the Commission sign the Water Accounts commitment for the month of December 2018 in the amount of \$1,502.43 and the Sewer Accounts commitment for the month of December 2018 in the amount of \$2,556.36. The motion seconded by Commissioner Barber. Voted unanimously.

Leino Park Bridge

The Commission discussed the inquiry by Senator Dean Tran's office regarding the town taken ownership of the private bridge.

Wachusett Brewery Industrial Pretreatment Program discharge permit

The Director apprised the Commission of the brewery permit application that was submitted to the City of Fitchburg. He stated that the town would be issuing a letter to the brewery requiring sample and flow monitory.

Draft Phase II Report Upper Reservoir Dam

The Director apprised the Commission that the 6-month inspection of the dam was completed recently. The Director noted that the Army Corps of Engineers is reviewing ownership of the auxiliary culverts and that the federal government shutdown has delayed the review

Ellis Road Water Storage Tank Replacement Project

The Director apprised the Commission of the remediation proposal for paint and soil at the tank site for lead and PCBs. The Director will be discussing the proposal with the tank design consultant, Wright-Pierce, and will provide an update at the next meeting.
