6:01 PM Commissioner Barber made a motion that the Commission approve the meeting minutes of January 31, 2022. The motion seconded by Commissioner Butterfield. Voted unanimously.

6:02 PM Commissioner Barber made a motion that the Commission sign the Sewer Accounts commitment for the month of February 2022 in the amount of \$363.03 and the Water Accounts commitment for the month of February 2022 in the amount of \$454.84. The motion seconded by Commissioner Butterfield. Voted unanimously.

Water System Emergency Response Plan (ERP) Approval

The Director reviewed with the Commission the updated ERP required by the AWIA 2018. The update also required a risk and resilience assessment be completed for the system.

6:07 PM Commissioner Butterfield made a motion for Commission to adopt and sign the updated ERP. The motion was seconded by Commissioner Barber.

Draft Town Financial Policies

The Director and Commission discussed revisions to the draft policies for the Enterprise Funds. The Director will forward the draft versions of the policies for their review.

Wastewater IMA- Update

The Director informed the Commission that Town Counsel reviewed the Draft IMA with minor comments. The City of Fitchburg will move forward with the draft as amended by town counsel.

Old Town Farm Road Culvert Replacement- Update

The Director informed the Commission that a Notice of Intent will be filed with the Conservation Commission. The plan for construction is to shut down the road for a weekend and compensate residents.
