6:00 PM Opened Meeting at Public Works Department Office. Reviewed and signed bills for payment.

6:05 PM Commissioner Butterfield made a motion that the Commission approve the meeting minutes of March 28, 2022 and April 11, 2022 as written. The motion seconded by Commissioner Barber. Voted unanimously.

#### Contract Extensions

6:06 PM Commissioner Butterfield made a motion to award a contract extension with K.A. Honkala Tree Service for Tree Removal and Pruning Services in the amount of \$55,000.00. The motion seconded by Commissioner Barber. Voted unanimously.

6:06 PM Commissioner Butterfield made a motion to award a contract extension with Martinez Road Construction, Inc. for Structure Adjustments in the amount of \$15,225.00. The motion seconded by Commissioner Barber. Voted unanimously.

#### Draft Sewer Service Area Bylaw

The Director discussed with the Commission the draft bylaw that he shared via email. He will have copies at the next meeting for the Commission to review and markup.

#### Annual Water/Sewer Rate Review

The Director continued discussion with the Commission for FY2023 rate increases. His projections suggest to increase the sewer rate by 5% (6.5% increase from City of Fitchburg) and no water rate increase and see the effect on the budget when the Ellis Rd tank and Shady Ave tank projects are complete and any capital improvements at Regional Water Treatment Facility.

6:21 PM Commissioner Butterfield made a motion for a 0% increase in the water rate and 5% increase in the sewer rate for FY2023. The motion seconded by Commissioner Barber. Voted unanimously.

#### Upper Reservoir Dam Culvert Replacement- Update

The Director updated the Commission on remaining items to be completed, e.g. driveway and lawn repairs.

#### Other items:

- 6:46 PM Commissioner Barber made a motion to approve the abatement request for 3 Lovell Street to include 50% abatement on the water overage and 45% abatement for the sewer overage. The motion seconded by Commissioner Butterfield. Voted unanimously.
- Chairman Emerson discussed water restrictions in place in the City of Gardner and has asked that we post water conservation messages in an effort to help with future drought conditions
- The Director noted the Welcome to Westminster event at the library on 6/9/2022 from 5-7 PM
- The Director noted that there is a PFAS public meeting for property owners in the Bean Porridge Hill Road and South Ashburnham Road area hosted by Mass DPH and DEP on 6/8/2022 at ORHS auditorium from 6:30-8:00 PM

6:54 PM Commissioner Barber made a motion to adjourn. The motion seconded by Commissioner Butterfield. Voted unanimously.
