6:00 PM Opened Meeting at Public Works Department Office. Reviewed and signed bills for payment.

6:01 PM Commissioner Barber made a motion that the Commission approve the meeting minutes of May 31, 2022 as written. The motion seconded by Commissioner Butterfield. Voted unanimously.

Wachusett Mountain Sign- Worcester Road and Mile Hill Road

6:03 PM Commissioner Butterfield made a motion that the Commission approve the replacement sign for Wachusett Mountain at the intersection of Worcester Road and Mile Hill Road and further that the new sign will occupy the same footprint as the existing sign and will have no increased impact on visibility as the existing column closest to Worcester Road is not part of the new design. The motion seconded by Commissioner Barber. Voted unanimously.

Current Drought Status/Water Restriction

Sewer Moratorium

The Director apprised the Commission that Town Counsel had approved removing language in the moratorium for unimproved lots on town sewer. Counsel removed lots that are unimproved.

6:07 PM Commissioner Barber made a motion that the Commission sign the 2-year sewer moratorium due to flow constraints in the Sewer Intermunicipal Agreement with the City of Fitchburg. The motion seconded by Commissioner Butterfield. Voted unanimously.

Road Paving & Resurfacing- Update

The Assistant Director apprised the Commission that street line painting is scheduled for Mile Hill and Bolton Roads. He also discussed work planned on South Ashburnham Road for FY23.

Draft Town Financial Policies

Complete Streets Plan Development- Update

The Director apprised the Commission that the Select Board will be voting on the Tier 1 Complete Streets Policy so that the work can progress to Tier 2 Prioritization Plan. He further indicated that the Town did not receive awards for the Shared Streets and Spaces grant not the Safe Routes to School grant.

Wastewater IMA- Update

6:16 PM Commissioner Butterfield made a motion for the Commission to sign the 2-year Sewer Intermunicipal Agreement amendment with the City of Fitchburg. It was noted that the City is not prepared to negotiate additional flow for the Town as they are still working through sewer separation projects as well as finalizing the wastewater management plan. The motion seconded by Commissioner Butterfield. Voted unanimously.

Old Town Farm Road Culvert Replacement- Update

The Director apprised the Commission that the bid opening for the project will be held on Thursday June 30, 2022. Pre-bid site conference was held on Thursday June 23, 2022. He has concerns regarding schedule, material supply and costs.

Wachusett Brewery Industrial Pretreatment Program- Update

Ellis Road Water Storage Tank Replacement –Update

The Director apprised the Commission that the contractor has the vault in place. The contractor was setting the forms for the tank today.

Route 140 Reconstruction and Improvements Project Update

The Director apprised the Commission he met with the appraiser to walk properties impacted by the project. They were able to meet with approx. 75% of the owners to discuss the project, appraisal process and their concerns.

The Director apprised the Commission that the street line painting has been pushed out but they must have it complete by Thursday June 30, 2022. We are holding full payment until job is complete.
