6:00 PM Opened Meeting at Public Works Department Office. Reviewed correspondence and signed bills for payment.

6:01 PM Commissioner Butterfield made a motion that the Commission sign the Sewer Accounts commitment for the month of September 2020 in the amount of \$926.19 and the Water Accounts commitment for the month of September 2020 in the amount of \$1,309.02. The motion seconded by Chairman Emerson. Voted unanimously.
