6:00 PM Opened Meeting via teleconference call.

6:02 PM Commissioner Butterfield made a motion that the Commission approve the meeting minutes of November 23, 2020 as written. The motion seconded by Commission Barber. Voted unanimously.

#### Abatement request 128 Main Street

The Commission continued discussion of the abatement request from the last meeting. The Director updated the Commission on install date of the deduct meter of September 11, 2020 and that the recirculating pond goes through the deduct meter.

6:17 PM Commissioner Butterfield made a motion that the Commission approve a sewer abatement for 128 Main Street in the amount of \$241.63. The motion seconded by Commission Barber. Voted unanimously.

### Winter Operations Update

The Director and Asst. Director updated the Commission on winter operations to date.

#### DPW Capital Plan

The Director, Asst. Director and Commission discussed future Bacon Street sewer extension to Public Works, future capital upgrades at Regional Water Treatment Facility (SCADA, intake Meetinghouse Pond, roof, residuals handling). The Director additionally apprised the Commission that Fitchburg is looking to update the water IMA.

#### FY2022 Budget

The Commission, Director and Asst. Director discussed the budget and article requests for FY2022.

#### Whitmanville Road Bridge Project Update

The Director updated that Commission on the project. The utility companies are expected to start pole installs in January 2021. Once complete, the bridge will be closed and detour started on Whitmanville Road.

6:46 PM Commissioner Butterfield made a motion to sign the MassDOT Small Bridge Reimbursement Request for Narrows Road bridge for \$6,076.72. The motion seconded by Commissioner Barber. Voted unanimously.
