6:01 PM Commissioner Barber made a motion that the Commission sign the Water Accounts commitment for the month of May 2021 in the amount of \$290.24 and the Sewer Accounts commitment for the month of May 2021 in the amount of \$159.31. Ellis Road Water Storage Tank Replacement Project

The tank replacement was bid on May 26, 2021 with bid of \$1,533,829 from Statewide Aquastore, Inc.

Route 140 Reconstruction and Improvements Project Update

Narrows Road Bridge Project Update

The Director updated the Commission on the project. The contractor is working on submittals for approval by the DPW consultant, Green International Affiliates. The project is expected to start in June 2021.

Upper Reservoir Dam culvert repair

The Director updated the Commission on the project. Beta Group will be submitting the culvert repair plans to the Office of Dam Safety for approval/permit.

Town Farm Road Project Update

The project was bid on June 9, 2021 with low bid of \$797,220.70 from Commonwealth Construction & Utilities, Inc.

-The Commission reviewed an abatement request for 71 Main Street.
