6:00 PM Opened Meeting at Public Works Department Office. Reviewed correspondence and signed bills for payment.

6:01 PM Commissioner Butterfield made a motion that the Commission approve the meeting minutes of April 27, 2015 as written. The motion seconded by Commissioner Ryder. Voted unanimously.

6:02 PM Commissioner Butterfield made a motion that the Commission sign the Sewer Services Account commitment for the month of April 2015 in the amount of \$93.48. The motion seconded by Commissioner Ryder. Voted unanimously.

6:03 PM Commissioner Butterfield made a motion that the Commission sign the Water Services Account commitment for the month of April 2015 in the amount of \$142.92. The motion seconded by Commissioner Ryder. Voted unanimously.

6:04 PM Commissioner Ryder made a motion to mill and pave the section of Oakmont Avenue from East Gardner to North Common/Mossman Road with MassDOT Winter Recovery Assistance Program (WRAP) monies. The motion seconded by Commissioner Butterfield. Voted unanimously.

6:05 PM Commissioner Ryder made a motion to award the contract for Sidewalk Replacement on Elliott & Pleasant Streets to Borges Construction Inc. of Ludlow, Massachusetts. The motion seconded by Commissioner Butterfield. Voted unanimously.

6:07 PM Commissioner Butterfield made a motion to award the contract for a new water/sewer pickup truck to Liberty Chevrolet of Wakefield, Massachusetts. The motion seconded by Commissioner Ryder. Voted unanimously.
