Early voting will be held in person at the Westminster Town Hall on Saturday, February 24th from 11:00 am to 5:00 pm and during regular hours of operation, which are Monday 7:00 am to 7:00 pm and Tuesday through Thursday, 7:30 am to 4:30 pm.

The last day to register to vote for the March Primary or to change your party enrollment is February 24, 2024. We will have in person hours from 9:00 to 5:00 pm for voter registration. M. Horrigan presented the paperwork for their signatures, one page for each year for the next ten years. The amount is \$1.6 Million from U.S. Bank at 5% interest for the next 8 years and 4% interest for the last two years maturing in 2034.

CONTRACT - DEPARTMENT OF FIRE SERVICES GRANT:

S. Albert made a motion to approve and sign the contract with the Executive Office of Public Safety and Security — Division of Fire Services for \$15,500 for the purchase and replacement of firefighter safety equipment. The motion was seconded and passed unanimously.

DISTRICT LOCAL TECHNICAL ASSISTANCE (DLTA) GRANT — MBTA COMMUNITIES:

S. Albert made a motion to approve the DLTA application to the Montachusett Regional Planning Commission to assist with the MBTA communities zoning overlay requirements set forth by the State. The motion was seconded and passed unanimously.

MRPC has been assisting the Town through this program for the past 2 years and this would be a continuation of that service.

NEW BUSINESS:

LIMITED ENGLISH PROFICIENCY (LEP) PLAN:

S. Albert made a motion to adopt and implement a LEP plan that is a requirement as a recipient of federal funding. The motion was seconded and passed unanimously.

As the Town is in receipt of multiple federal grants at this time, we have drafted the LEP Plan for distribution to departments and placement on our website.

The policy and plan outlines that the Town shall take reasonable steps to provide persons with LEP meaningful access to business conducted by the Town at no cost to the person with Limited English Proficiency Plan.

S. Albert made a motion to adjourn, the motion was seconded and passed unanimously. Meeting adjourned at 5:12 PM
