#### CALL TO ORDER

H. Billings called the meeting to order at 5:00 PM in room 205 of the Town Hall. She announced that the meeting was being recorded by Ashburnham/Westminster Community Media and no other recording devises have been brought to her attention.

# APPOINTMENT - COUNCIL ON AGING:

M. Banks made a motion to appoint Brenda Albert to the Council on Aging for a term to end June 30, 2026. S. Albert recused himself, H. Billings seconded the motion and it passed.

# **SET HOURS FOR ANNUAL TOWN ELECTION:**

- S. Albert made a motion to vote & approve the abbreviated hours for the Annual Town Election, from 7:00 am 8:00 pm to 9:00 am to 7:00 pm, due to lack of contested races. H. Billings voted yes and M. Banks voted no, the motion passed with a majority.
- E. Sheehan was present to explain the reasoning for the abbreviated hours of no contest in any of the races, less residents will come out to vote and there are little to no people for the town election that show up to vote between 7:00 9:00 am
- M. Banks stated that her reason for not voting for it is that the people that may want to stop by to vote before they go to work, that if it's not open that early the likelihood of them trying to make it later will not happen and feels that it would be a dis-service to the residents

### WESTMINSTER SENIOR RESIDENCES PROJECT DOCUMENTS:

M. Banks made a motion to approve to lease a portion of the town-owned property located at 6 Community Way to CCD Westminster Senior LLC for a term of 99 years for senior affordable housing purposed, and to execute, and to authorize the Town Administrator (or any Select Board member who is most readily available to sign and notarize documents) to execute on behalf of the Select Board, Ground Lease, Notice of Lease, Affordable Housing Restriction, and any and all other documents as may be necessary or appropriate to accomplish the foregoing lease. The motion was seconded and passed unanimously.

## ONGOING BUSINESS/MISCELLANEOUS

#### POLICE DEPARTMENT MUTUAL AID:

M. Banks made a motion to approve and sign the Local Mutual Aid Agreement. The motion was seconded and passed unanimously.

This agreement has been in place with neighboring communities and was originally executed by a former Select Board and Police Chief. This is an update to that agreement.

#### SMALL PROJECTS REQUESTS — REVIEW AND RECOMMENDATION:

The board reviewed the six board/committee submittals and recommended/suggested the following:

It was suggested that all of the Gazebo repairs should be officially submitted through Capital Planning due to all of the repairs throughout the whole Gazebo that need to be made and the overall cost of it, which is over the Small Project Request limit and reaches the Capital Plan threshold. The Gazebo would be able to be repaired properly and possibly have the opportunity to upgrade the underside storage area.

It was also suggested, that in reference to the Historical Commission's request for updates to the Farmer's Co-op, that Conservation Commission, Agricultural Commission address the Historical Commission's involvement, as Conservation Commission has ownership and wants to transfer the ownership to Agricultural Commission. It was agreed that the Farmer's Co-op does need a bathroom.

Select Board is still in review process and will make a determination at a future meeting

## **BUDGET AND ARTICLE REVIEW:**

The draft budget documents for FY2025, including the STM and ATM Articles list, warrants and general fund budget draft. These numbers reflect both AWRSD and Monty Tech Assessments, as well as various adjustments to several department budgets as requested at the last joint meeting. This includes a reduced amount in Police and Fire expenses, reduction in the Library budget of \$13,800 per AB vote and several other smaller adjustments.

One change has been made since the 3/18 meeting — based on feedback from Town Counsel, the Town Administrator recommends the removal of Article 22 for the Farmer's Co-op transfer of ownership. Legal transfer of ownership will trigger Article 97 legislation and a 1:1 land swap. Counsel suggests that the Conservation Commission and Agricultural Commission enter into internal agreements as it relates to the use and further utilization of the parcel.
