PUBLIC WORKS COMMISSION MEETING MINUTES

May 8, 2023

6:00 PM Opened Meeting at Public Works Department Office. Reviewed and signed bills for payment.

6:01 PM Commissioner Butterfield made a motion that the Commission approve the meeting minutes of April 10, 2023 and April 24, 2023 as written. The motion seconded by Chairman Emerson. Voted unanimously.

6:02 PM Commissioner Butterfield made a motion that the Commission sign the Water Accounts commitment for the month of April 2023 in the amount of \$301.99 and the Sewer Accounts commitment for the month of April 2023 in the amount of \$107.40. The motion seconded by Chairman Emerson. Voted unanimously.

Chapter 90 Project Request-Route 140 (Worcester Road)

The Assistant Director apprised the Commission that this request would be used for compensation for easements for the Route 140 project. Commissioner Butterfield made a motion to authorize the Chairman to sign the \$40,000 request for Chapter 90 reimbursement. The motion seconded by Chairman Emerson. Voted unanimously.

Abatement Request- 39 Ellis Road

Chairman Emerson read a letter from resident at 39 Ellis Road requesting a water abatement. The Commission reviewed the request for water abatement due to an undetected leak in the upstairs shower faucet and agreed to give a 50% abatement. Commissioner Barber made a motion to accept the abatement request. The motion seconded by Commissioner Butterfield. Voted unanimously.

Solid Waste Drop-Off Center Waste Oil Tank contamination- Update

The Commission discussed the response from Waste Management and would like frequent testing of the oil and also to do our own testing. Require they only receive oil in an oil container. The Assistant Director will send the Commission a draft that we can post on our Facebook page with requirements of drop off.
