6:00 PM Opened Meeting at Public Works Department Office. Reviewed and signed bills for payment.

6:01 PM Commissioner Barber made a motion that the Commission sign the Sewer Accounts commitment for the month of August 2022 in the amount of \$484.60 and the Water Accounts commitment for the month of August 2022 in the amount of \$1,016.61. The motion seconded by Commissioner Butterfield. Voted unanimously.

Petition to lay out White Pine Drive as a Public Way

The Director apprised the Commission that he received a request to accept White Pine Drive as a public way. He outlined the process to accept the road per Town Counsel.

6:03 PM Commissioner Butterfield made a motion that the Public Works Commission, acting as the Road Commissioners, vote its intention to lay out White Pine Drive as a public way, all as shown on a plan entitled "Street Acceptance Plan Westminster, Massachusetts", dated May 26, 2022, prepared by Dillis & Roy, Civil Design Group, which plan is on file with the Town Clerk, and to forward this vote and the plan to the Planning Board for its comments and recommendations pursuant to G.L. c. 41, §§81G and 81I. The motion seconded by Commissioner Barber. Voted unanimously.

The Director apprised the Commission that he received a request to accept Lighthouse Lane as a public way. He outlined the process to accept the road per Town Counsel.

The motion seconded by Commissioner Butterfield. Voted unanimously.

The Director discussed with the Commission that he is recommending using the same contractors as last year for snow plowing. He stated that the rates are based on MassDOT contract rates and increased about 10-17% over last year.
