RFD 10 Hy Road Tafuri

The Request for Determination for 10 Hy Road was approved at the meeting August 24, 2023. Signatures were needed and the Commission voted to sign the Determination with all in favor.

MINUTES OF AUGUST 3, 2023

The Minutes of August 3, 2023 were unanimously approved.

NOI ~ CONTINUATION 83 West Princeton Road Vanderhoof & Rielly

Chris Mossman requested a continuance for 83 West Princeton Road. The Commission unanimously agreed and this was continued to October 5, 2023

NOI 72 Worcester Road ~ CONTINUATION Normandin

The public hearing for 72 Worcester Road requested by Peter Normandin was opened. Chris Mossman represented Mr. Normandin and gave the overview of the project for a new single family home with septic, well, driveway, and associated grading. He discussed the project with Mr. Deline of the Water Department for the City of Fitchburg and agreed to move the easement for the hydrant. Erosion control measures were discussed and Mr. Normandin expects that the driveway will be paved. There were no further questions from the Commission after reviewing the plan and no questions from the audience. Tim Sheehan made a motion to approve the plan and seconded by Vic Pelletier. The plan was unanimously approved.

NOI ~ CONTINUATION 21 Rock Maple Lane Zhuravlyov

Lar Green of McCarty Companies requested a continuation of the public hearing for 21 Rock Maple Lane to October 5, 2023 as DEP has not issued a number. The Commission was in agreement.

RFD 102 North Common Road ~ CONTINUATION Bergeron

The public meeting for 102 North Common Road requested by Alison Bergeron for an addition to a single family home and minor tree removal within the buffer zone was opened. Alison Bergeron gave the overview of the project. Ms. Bergeron was asked to come in to the next meeting with the engineer and a complete plan including future work in the buffer zone. The Commission voted unanimously to continue to October 5, 2023.

NOI 25 Barrel Road ~ CONTINUATION Brisson

The continuation of the public hearing was continued to October 5, 2023 at the request of Ian Ainslie, PE, Meisner Brem Corporation as DEP has not issued a number.

RFD ~ CONTINUATION 8 Pine Road White

The continuation of the public meeting for 8 Pine Road was continued to October 5, 2023 at the request of the applicant.

NOI 76 Worcester Road Lot 1B Arsenault

The public hearing for the construction of a new single family home with septic, well driveway and associated grading at 76 Worcester Road was opened. Chris Mossman submitted proof of notification of abutters and gave the overview of the project. Mia McDonald of DEP has requested a stamped stormwater checklist showing compliance with MA Stormwater Standards as this lot is part of a residential subdivision of more than 5 lots. The Commission reviewed the plan and it was noted that DEP has not yet issued a number. The project was continued to October 5, 2023 to give the applicant an opportunity to comply with DEP's request.

AMENDMENT Route 140 #336-0946 Green International

A representative from Green International discussed minor modifications to the resource area impact changes proposed for this project. An Extension had been issued at the previous meeting on August 24, 2023. The proposed wetland replication area has not changed from the original plan and temporary wetland impacts will be restored. The amendment was unanimously approved by a motion by Tim Sheehan and second by Carrie Monty.

RFD 40 Shore Avenue Popinchalk

The public meeting requested by Seth Popinchalk for 40 Shore Avenue was opened. Mr. Popinchalk would like to remove an old wooden dock with a fully removable dock. He is currently waiting for Chapter 91 license approval. The Commission would like the Chapted 91 license before the RFD can be approved. Mr. Popinchalk was agreeable to continue the public meeting but may not be available on October 5th.

345 South Ashburnham Road

Peter Normandin will file a notice of Intent to replace the house that was destroyed by fire and would like to be on the agenda for the October 5, 2023 meeting.

Dan Bartkus explained of the duty of the Conservation Commission and the Wetland Protection Act to Tim Masters of 13 Woodland Drive.

The meeting was adjourned with all in favor at 7:45 pm.
