6:01 PM Commissioner Barber made a motion that the Commission sign the Water Usage Account Quarterly Billing Commitment for October 2022 in the amount of \$255,054.49 and the Sewer Usage Account Quarterly Billing Commitment for October 2022 in the amount of \$322,819.56. The motion seconded by Commissioner Butterfield. Voted unanimously

Drinking Water Public Notification- Total Trihalomethanes

The Director apprised the Commission that notifications will be mailed tomorrow for the quarterly non-compliance. The Director is looking at the feasibility of installing aeration systems in both water tanks to reduce the levels in the warmer months.

- The Director and Chairman Emerson apprised the Commission of their meeting with City of Fitchburg regarding the dam on Wyman Pond.
