## PUBLIC WORKS COMMISSION MEETING MINUTES

April 27, 2020

6:00 PM Opened Meeting via teleconference call.

Massachusetts Water/Wastewater Agency Response Network (MaWARN)
The Director, Assistant Director and Public Works Commission discussed MaWARN mutual aid assistance, response, membership pros and cons.

6:06 PM Commissioner Barber made a motion for the Public Works Commission to sign the agreement to become a member of MaWARN. The motion seconded by Commissioner Butterfield. Voted unanimously.

### Annual Water/Sewer Rate Review

The Director, Assistant Director and Public Works Commission discussed the revenue and expense projections for the Water and Sewer Departments. The Director proposed a 0% water rate increase and a 7% sewer rate increase (increase from City of Fitchburg). Chairman Emerson expressed concern with the 7% sewer rate increase and asked that the Director look at softening the 7% increase due to Covid-19 with a couple different rate scenarios for discussion at their next meeting. The Director raised concerns with how Covid-19 could impact water/sewer revenue projections for FY2021.

6:12 PM Commissioner Butterfield made a motion to not increase water rates for FY2021. The motion seconded by Commissioner Barber. Voted unanimously.

# Whitmanville Road Bridge Project Update

The Director apprised the Commission that the Board of Selectman will be voting the Order of Taking for the easements on April 27, 2020.

### Wachusett Brewery Industrial Pretreatment Program discharge permit

Nothing new to report. The Assistant Director will reach out to WBC to see if there is a schedule update.
