Meeting Minutes July 10, 2017

Call to Order:

The meeting of the Zoning Board Of Appeals was called to order at 7:05 p.m. at Westminster Town Hall, 11 South Street, Westminster, MA by Acting Chairman Aime DeNault.

Roll Call:

The following members were present: Acting Chm Aime DeNault, Members Robin Brasili and Peter Romano and Associate Member John Bowen. Town residents Victor Pelletier and Jon Wyman were also present.

Approval of Minutes from previous meeting(s):

Robin Brasili made a motion to accept the minutes from *April 20, 2017, May 2, 2017*, and *May 16, 2017*, with acknowledgment that a minor correction in the minutes from May 16 will be made to reflect an accurate date for the next scheduled meeting. The motion was seconded by Peter Romano and approved by a unanimous vote.

Case #17-02 - Lead the Way Development - 190 & 194 Narrows Road

Mr. Bowen made a motion to table the discussion on Case #17-02 as representatives for the case could not be present. The motion was seconded by Mr. DeNault and approved by a unanimous vote.

Case #17-03 - Victor Pelletier - Laurel Lane, Map 138, Lot 40

Applicant's testimony:

At 7:15 p.m. Mr. Pelletier discussed his appeal to the ZBA. Mr. Pelletier seeks to install a Reeds Ferry Shed on his property. The shed would be 14 feet by 22 feet with electricity and would require the removal of two trees. Mr. Pelletier's shed would be used for storage and meets the

setback requirements according to town zoning bylaws. At this time, he has no plans to build additional buildings on the property.
