VOTE TAKEN AT THE SPECIAL TOWN MEETING, NOVEMBER 14, 2023

An affirmative vote was taken at this time to accept the provisions of MGL Chapter 39, Section 15, which allows the Moderator to dispense with a count in matters requiring a two-thirds vote by statute, where the vote is unanimous or clearly overwhelming at this Annual Town Meeting.

ARTICLE 2. Voted to amend the Westminister General Bylaws (Chapter 25 of the Code of the Town of Westminister, Massachusetts, §25-4 and §25-6) by making the following amendments with text to be deleted in strikethrough and text to be added in bold:

§ 25-4. Convening and adjourning times of Annual Town Meeting.

The business session of said Annual Town Meeting shall be convened at ~~1:00 p.m.~~ **10:00 a.m.**, and if there remain articles unacted upon at 6:00 p.m., the Meeting shall be adjourned to the following Saturday at ~~1:00 p.m.~~ **10:00 a.m.**, unless otherwise voted.

§25-6. Hours for Special Town Meetings.

Special Town Meetings may be held on any weekday, but not earlier than ~~7:30 p.m.~~ **6:00 p.m.**, except that on Saturday they shall not be held earlier than ~~1:00 p.m.~~ **10:00 a.m.**
